- Spent couple days wrapping up post Convention financial work Convention bills, Director Expense cheques, refund cheques for Convention volunteers

 Contacting some Ag Societies to get them to update their info in AssistExpo and pay their Membership fees. If they don't get AssistExpo updated, their information will not be in the Directory or Brochure.

- At least one fair has already cancelled, and several have cancelled events in their facilities.
- I am working on a letter to send to Premier and Minister of Agriculture to ask them to ensure that Agricultural Societies are considered in their programs to help business in Ontario. CAFE is in discussions with the Federal Government regarding assistance for Agricultural Societies across Canada.
- Sent a survey to Ag Societies to see how many Passports, Directories and Brochures they need this year. Original idea was to cut back on unnecessary printing costs. With the possibility of sending out material by Canada Post, this will also reduce postage costs.
- Disappointed that some Districts are still not sending me dates and locations for their Spring and AGM meetings and Judging Schools so I can post on our website.
- Had an email from an Ag Society question about information they had been told at a District meeting regarding the use of single use plastics. I responded that there had been absolutely no discussion by the OAAS on that subject.
- Feel that we need to put the website replacement on hold for the time being with the uncertainty of what is happening at this time and the financial implications.

- We have a meeting lined up with the Ontario Horticultural Society to discuss the use of some of their materials in our updated Agricultural and Horticultural Judging Standards Handbook. We were working with the Ottawa Valley Farm Show to have their Seed Judging School as an accredited OAAS Judging School but unfortunately it has been cancelled.
- Some communication with CAFE around the proposed changes to Livestock Traceability Requirements. No timeline at this time for the new proposals.
