15. Manager's Report

Here are some highlights of my report that I sent to you earlier

- Busy planning our weekly webinars still have around 150 people attending. All the video call recordings are on our website. Just confirmed Doug Reddick and Rick Berthiaume from OMAFRA for next Wednesday
- Zoom meetings pretty much every day have had up to 4 or 5 zoom meeting in a day
- Both websites have been updated; the feedback has been very positive. John did not charge us for the update to the Ontario Fairs website – he spent most of a week on it. The update means that I only have to input the Fair date once for each fair instead of 3 times.
- I have been able to attend most of the District spring meetings I have really enjoyed being part of them. It's not possible or feasible for me to participate in-person meetings in other years, so this has been a new experience and seems to have worked quite well.
- Sent letters to MPP's and working on another set of letters for MPP's MP's going out ASAP. I have had it stressed to me from different levels of government − 1) letters, lots of personalized letters to various levels of government − no bulk "Dear MPP)" letters − they get ignored. And 2) they are looking for facts and figures when you are requesting assistance or other funding. Only 50% of our fairs provided TREIM reports or the information we were looking for. We are going to have to emphasize determining what information we will need in the future and start collecting it yearly.
- Updating the website with fair cancellations regularly at around 100 cancellations
- Meeting weekly with Tobias Clark from OMAFRA
- Been working on our 2021 budget best case/ worst case??
- Please follow up with your District Executive regarding Vulnerable Sector Checks they should be
 contacting their local Police Services as soon as it is deemed safe by the government. We have
 approximately 20 people that have not completed it. I will send out an updated letter to you to
 provide to the District Directors to take to the police.
- Three fairs still outstanding
- We need to decide whether or not we will print the 2020 Directories and Brochures.

Motion by Doug Yeo that we cancel printing the 2020 Directories and Brochures **Seconded** by Leonard Riopel **Carried**

We will ask our sponsors to carry forward sponsorship to next year. It will save money on printing and shipping.

Fair Passports? Do we need to send them out?

We offer people a credit towards next year or refund if required.

Hold off on sending out passports – some later fairs may still need them.

We will notify the Agricultural Societies and Districts that the OAAS will not be sending out the Agricultural Society and District packages containing the Directories, Brochures, passports and other supplies.

Fall Board Meeting – should decide at the next meeting if what format our Fall Meeting will be

16. Convention Administrator Report

Thank the board for the care package at my door – it helped my recovery

- OAAA took over the responsibility of booking the suites. Seven hospitality suites, plus corner suites
- Received 11 requests offered smaller suites to other 4 groups. They have to contact the hotel with their credit card
- Provincial Director got an email with room info call the hotel with credit card info asap by June
 1.
- Ambassador update webinar last Thursday Paula Ellis joined the call. CNE will allow any ambassador from 2019 and 2020 to participate in 2021. Don't know if there will be one or two competitions – depends on the number of participants.
- Ambassador Program committee meeting to discuss the Convention Program
- Seminars meeting next week
- Planning on full Convention next February
- Competitions What will Convention 2021 Competitions look like.
- Most fairs will be cancelled or modified.

Linda – agree that we don't have any Competitions next year. Quilts from Country Heritage for a display. Displays from fairs – ribbons, etc.

Guy Scott has offered to set up at least one room of fair History

Carol – we need to suspend the competitions for 2021.
