Some Districts are waiving their District fees

If we are successful accessing membership dollars from government, we will refund the equivalent amount of fees to the Agricultural Society

If we decrease the value – will people expect that it will be cheaper in the future – undervaluing the convention

Making it available at night – maybe we will get more people that can't take 3 days off going to Convention. May get a younger demographic to attend – Board may not have sent younger members prior

Can we get some fairs doing webinars that do not normally attend?

Had a good turn out for our webinars

People will be bored in February – cannot go on vacation – will be looking for something to do Offer early bird rates – absolutely no cancellations

Record AGM – and put on website – could do it annually

Do not want to devalue our product – we have an established record of attendance
