• Judging Program

• Delay Judges' Requirements deadline until January 1, 2023

With the continued public health stipulations, I don't expect that any judging schools will be held before the fall to allow Judges to remain certified - proposing that we defer the Judges' Requirements deadline until January 1, 2023

Motion by Heather Owens that the OAAS modify the "Requirements for OAAS Certified & Apprentice Judges Policy" to update the December 31, 2021 deadline to January 1, 2023. . **Seconded** by Heather Dillon **Carried** Yes - 18; No - 0; Abstain - 0

• New Ag & Hort Judging handbook

We planned that we would move forward with the Agriculture & Horticulture Judging Standards Handbook after the 2020 Convention, but that was put on hold by COVID. Our OHA contact recently emailed us to see what the status was on our Judging Standards, and we indicated that we are hoping to start moving forward in the next couple of months.

• Request from Ottawa Valley Seed Growers

Early last year, we received a request for the Ottawa Valley Seed Growers to see if the OAAS was interested in working with them on their Seeds and Crops Judging School last spring. They have recently contacted us to involve the OAAS in their latest project, which is a virtual Judging School.

They are aware that our board decided last year that we were not interested in online judging schools

I would like to propose that we work with them to see if it is possible to create Judges' training that would meet the standards that the OAAS is working to achieve with its Judging Program, as well as create a process to ensure that the participants have participated fully and understood the material.

• Request for virtual judging school

We received a request from a District wondering if it was possible to have virtual judging classes or schools. .

The hands-on component in an in-person Judging School is essential to properly train and assess our Judges. The equipment and expertise required to host a virtual Judging school would also be prohibitive in many Districts. The OAAS does not have the staff or budget at this time to investigate virtual training.

> **Motion** by Glen Syme that the OAAS, in consultation with the Judging Panel, will create a framework and criteria that the virtual Judging School proposal must meet for the Board and Judging Panel to consider their proposal for approval. **Seconded** by Brian Slaughter **Carried** Yes – 16; No – 1; Abstain – 0

Motion by Glen Syme that the OAAS respond to any District, Agricultural Society, group or person interested in hosting a virtual Judging School must submit a detailed plan and outline within the Virtual Judging School framework and criteria that was created by the OAAS of how they would plan and carry out the Judging School prior to it being considered for approval. **Seconded** by Liz O'Gorman-Smit **Carried** Yes – 18; No – 0; Abstain – 0

Beth - District was looking at providing information on Best practices, tool kit, etc. to keep Judges engaged until we get back to in-person judging

Recommended by the Judging Panel that we post the Homecraft Judging Standards Handbook on the website for a limited time to help keep Judges engaged

A complimentary one will still be provided at Judging School as per the previous motion.

Motion by Leonard Riopel that we post Homecraft Judging Standards Handbook on line and for a limited time. Seconded by Heather Owens
